





Can you please help answer the following:

What is the age of the substation and do you have maintenance and repair records? Installed new in 2008. We do not have maintenance records from GE and the site owner has only done inspections.

What is the cost of the mainline power if we buy the substation and supply power through our substation? That is a question for National Grid. I have attached a bill estimate that Grid provided for demonstration purposes only to a prior prospective tenant in 2019. Along with that attachment was Grid notes at that time in blue below. I am sure their current representatives will be able to address everything further.

"Bill Estimate

Attached please find a bill estimate for illustrative purposes only. You'll note the standard and discounted delivery rate. This is the most basic estimate. We are deregulated in New York, so you can take supply from a third party. The supply cost used is a blended average, which is higher than current cost.
